1. Call to Order

5. Year-to-Date Financial Statement and Summary

(ITEM #5)

Ms. Henry presented the year to date November 30, 2013 financial statements to the Authority, noting that FY14 is on target, but in November there were three pay periods, overtimes, and holiday pay. Chairman Preston Elliott called for acceptance of the financial report. *Mr. Dale Thomas motioned, Ms. Nancy Fletcher-Blume seconded the motion. Motion carried unanimously.*

6. Transit Report (ITEM #6)

Ms. Henry reported the ridership. Fare Box Revenues continues to rise, with December being best month to date. Ms. Henry also informed the Authority operating cost and passenger costs are running less, more efficient. Chairman Preston Elliott called for acceptance of the transit

report. Mr. Dale Thomas motioned, Ms. Nancy Fletcher-Blume seconded the motion. Motion carried unanimously.

NEW BUSINESS

7. Acknowledgement of Transit Center Preventive Maintenance Plan (BAI 01-16-14-7)

Ms. Henry presented the Transit Center Preventive Maintenance Plan. This plan is to ensure proper maintenance of USDOT funded properties. She noted this document will be a living document that changes as necessary. Chairman Preston Elliott called for acceptance of the Transit Center Maintenance Plan. Mr. Hays Waldrop motioned, Mr. Dale Thomas seconded the motion. Motion carried unanimously.

8. Community Outreach Report

Ms. Varallo updated the Authority on the Girls Scout Patch approved in 2013. There has been national attention as Franklin Transit Authority is the first public transportation patch available for Girl Scouts. Ms. Henry informed the Authority of one Daisy troop that has already visited, with Junior Troop scheduled for January 27. Looking forward to 2014, Ms. Varallo plans on more publicity, education, and customer surveys.

- 9. Report of Executive Director
- a. Triennial Review Update: Ms. Henry thanked the TMA staff for their worked, and promised to be a stronger service because of the review. There were 9 findings, many which have already been cleared, but staff is working with Federal Transit on three remaining items-ADA. Title VI, Subrecipient Oversight.
- b. Holly Trolley Updated: Ms. Henry informed the Authority of a complete sell out for Holly Trolley this year, a total of 967 seats.
- c. Meeting Schedule: Ms. Henry suggested a monthly Authority meeting until Transit Service Contract is complete.

10. Transit Contract Discussion – Chairman Preston Elliott, Authority members and COF Lega
The upcoming expiration of the contract for transit services was discussed and it was voted to request City staff to begin the process of the issuance of a request for qualifications or request for proposals. The vote was unanimous.
